

SWIMMING LESSONS on board the A-ROSA SENA ENROLMENT & CONSENT FORM

Dear Families,

It's a pleasure to have you on board the A-ROSA SENA!
We look forward to welcoming you and your children to our swimming lessons.

We will be starting tomorrow! However, to ensure that our swimming lessons can run smoothly, we would like to draw your attention to some important points that you must follow for your child to participate in our swim course.

Our beginner and intermediate swimming lessons are aimed at children between the ages of 4.5 and 7 who would like to learn how to swim.

The lessons are taught by a professional swimming instructor from the *Wasserlust* swimming school.

During the first lesson, the swimming instructor will determine if the children meet the requirements for the course by playing some aquatic games. The aim is to ensure that children are actively participating in the lesson, can let go of their parents, can follow instructions and are able to move freely in the water.

Each participant must be in good physical health at the start of the course. With your signature, you confirm that your child is in a good health and that there are no serious illnesses (e.g. organ damage, contagious diseases) that would prevent your child from attending the course*. Any health risks must be discussed with a doctor in advance. Physical or mental limitations of the participants must be shared with the instructor before the start of the course. The swimming instructor has the right to exclude participants from the course without refunding their course fee in the event of visible contagious disease (e.g. conjunctivitis, severe cold) or misbehaviour. The swimming instructor appointed by the swimming school is the responsible supervisor during the course.

Now we can get started! The entire A-ROSA SENA team wishes you and your kids lots of fun with your *Wasserlust* swimming lessons.

If you have any questions now or at any time while you're on board, our staff will be more than happy to help you.

In order for your kids to participate in the swimming lessons, please read the following rules carefully, fill in the required information and hand in the enrolment form to the swimming instructor before the start of the course. Please note that your children will only be allowed to participate if we receive the signed enrolment & consent form.

1. Safety Instructions & Photo Permission

The safety and well-being of your children are our top priorities at A-ROSA. Nonetheless, there are areas on a river cruise ship which might pose a danger, especially to children. For this reason, we would like to make you and your children aware of a few points in particular:

- No running on the ship. (There may be slipping hazards, especially around the pool and after floor cleaning)
- Hygiene is another one of our top priorities on board. Therefore, to ensure the health of our guests and crew, we ask you to observe the hygiene rules currently in place on board, including the pool area.
- Be careful near the railing – climbing is not allowed here.

By signing below, you confirm that you have informed your child of the above-mentioned risks and rules and that they must follow the instructions of the swimming instructors.

Without signing this consent form, your child will not be able to participate in the swimming lessons.

In order to capture the swimming course pictorially, photos and videos may be taken as part of a photo shoot by A-ROSA. These photos and videos may be published and distributed by A-ROSA on the Internet and on image media without any time or place restrictions. If you do not agree with this and your child does not participate in the photo shoot, please inform the swimming instructor.

2. Course fees

Please let us know if you have already paid for the swimming course.

- The entire swimming course in the amount of 149 EUR was booked.
 - The swimming course was booked and paid in advance.
 - The swimming course fee of 149 EUR must still be paid on board via the on-board account.

* Serious illnesses in the above sense are primarily cardiovascular diseases, asthma or asthmatic bronchitis, otitis media and sinusitis, serious skin diseases (eczema, skin fungus) and tendency to seizures.
