In order to ensure this at all times and to make your holiday as safe and relaxing as possible, we can only allow those in full health, who have proof of a complete COVID-19 vaccination or have recovered from COVID-19 (for guests 12 years and older), access to our vessels.

Please note the following:

TRAVEL PREPARATION



- Please read your travel documents carefully.
- You will find daily updates here: www.arosa-cruises.com/travelinformation. Details of possible entry requirements can also be found here.
- Be sure to check the regulations that apply to your flight or train, and allow extra time for security checks if necessary.
- Guests 12 years and older need one of the following proofs to participate in A-ROSA voyages:
 - Proof of complete vaccination against COVID-19 (valid from 14 days to 9 months after the last required vaccination dose or, in the case of successful booster vaccination, from the day of booster vaccination until further notice).
 - Evidence of recovery from COVID-19 (29 days to 6 months after positive PCR test result).
- We recommend a digital EU COVID certificate for travelling - either as a printed QR code or as one of the EU-wide connected apps.
- Children up to and including 11 years of age are exempt from the proof requirement.
- We ask you to always take a sufficient number of medical masks with you so that you can change them regularly. In addition, we also recommend carrying FFP2 masks, as in some regions it is compulsory to wear such protection.

EXCURSIONS & TRANSFERS



- The wearing of a mouth and nose protection is compulsory for all guests on the excursion coach. Depending on local regulations, it may also be necessary to wear such protection throughout the duration of the excursion and outside the coach. Our crew and guides will of course familiarise guests with local pandemic containment measures in good time.
- If possible, please bring your **OWN HEADPHONES** (with jack plug) to use the audio guides. You can also purchase disposable headphones on board for a price of €1.50.
